

Raw Traditional Chicken Fingers

Containing up to 12% of a Solution

Cooking Instructions: Preheat oven to 450°F. Spray a foil-lined pan with cooking spray, then arrange chicken fingers in a single layer. Bake 5 minutes; flip and cook 5 additional minutes or until the internal temperature measured by a meat thermometer reads 165°F.

Ingredients: Chicken Breast Tenderloins (Containing Water, Salt, Roast Chicken, Sodium Phosphate, Sugar, Onion Powder, Natural Flavoring), Bleached Wheat Flour, Water. 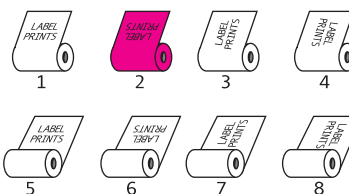
